By accessing or using the Service, you agree to the collection, use, and disclosure of your information in line with this Privacy Policy. If you don’t agree, please don’t access or use the Service.

We may update this Privacy Policy at any time without prior notice. We’ll post the updated version on the Service. Information We Collect:

We may collect and process the following personal data:

How We Use Your Information:

We use the info we collect for:

- Marketing/Promotions
- Targeted Advertising

If we want to use your data for any other purpose, we’ll ask for your permission first. We’ll only use your info for the specific reason you agreed to—unless the law says otherwise.

Sharing Your Information:

We won’t share your personal info with third parties without your consent, except in these limited cases:

- Data collection & processing

We require these third parties to use your data **only** for the purpose it was shared and not keep it longer than needed.

We may also disclose your information in these situations:

- To comply with laws, regulations, court orders, or legal processes.
- To enforce our agreements with you, including this Privacy Policy.
- To respond to claims that the use of the Service violates someone's rights.
- If our Service or company gets merged with or acquired by another company—your data may be transferred as part of the deal.

How Long We Keep Your Info:

We'll keep your personal data between 90 days and 2 years after your account is closed or as long as needed to fulfill the purposes mentioned here. Sometimes we may have to keep some data longer—for legal reasons, fraud prevention, or to protect our legal rights. Anonymized or aggregated data (which can't identify you) may be kept indefinitely.

Your Rights:

Depending on the law that applies, you may have rights to:

- Access, correct, or delete your personal data
- Get a copy of your data
- Limit or object to how your data is processed
- Request data portability
- Withdraw consent you previously gave
- File a complaint with the appropriate authority
