INFORMATION ON THE PROCESSING OF PERSONAL DATA

This information notice supplements what is provided in the general information notice on the <u>vivaticket.it</u> website.

In accordance with EU Regulation 2016/679 (General Data Protection Regulation), the Organizing Committee of the World Masters Table Tennis Championships wishes to inform you about the processing of your personal data.

1 - DATA CONTROLLER.

The Organizing Committee of the World Masters Table Tennis Championships, Olympic Stadium - Curva Nord, Rome, Italy, in the person of the Legal Representative.

2 - PURPOSES OF PERSONAL DATA PROCESSING AND LEGAL BASIS OF DATA PROCESSING (Reference. Art. 6 of EU Regulation 2016/679).

We inform you below of the purposes of the operations of collection, storage, and processing of your personal data by the Autonomous Data Controller who will process your data:

a. for marketing and promotional purposes of the World Masters Table Tennis Championships Event Rome 2024, including the sending of newsletters, through automatic means, such as e-mail and SMS, as well as traditional means, such as telephone contact with operator, all in full compliance with the principles of lawfulness and fairness and the provisions of the law; this purpose concerns only those users who have expressed optional consent and will still be guaranteed the issuance of the access ticket even in case of non-consent;

b. if Organizer of the events for which access tickets are purchased, also for the issuance of the title and participation in the Event World Masters Table Tennis Championships Rome 2024, on the basis of the purchase contract (art. 6 paragraph 1 letter b) Reg. 2016/679).

3 - PROCESSING METHODS

Your data will be mainly processed by electronic means, in the manner and to the extent necessary to pursue the above purposes, in accordance with the principles set out in Article 5 of EU Regulation 2016/679. The data are stored in electronic archives with full assurance of the adequate security measures required by the New European Regulation 2016/679.

4 - DATA STORAGE

The data collected for marketing and promotional purposes will be stored in the databases of the Autonomous Data Controller and <u>vivaticket.it</u> until the data subject exercises their right to object or cancel through the methods made available for this purpose and indicated on the <u>vivaticket.it</u> website and in this document.

The Autonomous Data Controller, if Organizer of the events for which access tickets are purchased, will retain your data for the time necessary to carry out the administrative, accounting and tax purposes related to the relationship established and also arising from the obligations under the law, however, within the prescriptive terms set for the rights and obligations underlying the data processing plan.

5 - DATA COMMUNICATION

Personal data may be processed by data processors connected to the Autonomous Data Controller, that is, by professionals and personnel who for organizational and functional needs necessitate to process them, as well as by any third parties involved, therefore appointed as External Data Processors, as they are dutifully involved in the performance of the due activities. The processing will be limited to the sole purposes related to the provision of the services offered. The updated list of external Data Processors will be available from the Autonomous Data Controller. The Data Processors have been instructed in security and protection of personal data, with the prohibition, in particular, to disseminate or communicate personal data to further third parties,

except within the limits of the performance of services. The data may be disclosed to the Judicial Authority where necessary, including for organizational and security purposes related to the event.

The data will not be disseminated.

6 - DATA TRANSFER TO A THIRD COUNTRY

Personal data collected through the <u>vivaticket.it</u> website will not be transferred outside the European Union.

7 - RIGHTS OF DATA SUBJECTS

You, as "Data Subject", enjoy specific rights (art. 12 et seq. EU Regulation 2016/679) as set out below:

- to obtain confirmation of the existence or non-existence of personal data concerning you;
- to know the content and origin of the data, the purposes, and methods of processing;
- to verify the accuracy, ask for the updating and rectification of your data;
- that is, when interested, to request the integration, cancellation and transformation into anonymous form or the blocking of data processed in violation of the law, including those that do not need to be kept in relation to the purposes for which the data were collected or subsequently processed.

In particular you have the right to:

- to object at any time, for legitimate reasons, to the processing of personal data concerning you, even if pertinent to the purpose of collection, as well as to the processing of personal data for the purpose of sending advertising material;
- to request data portability;
- to revoke at any time the consent given, without affecting the lawfulness of the data processing carried out by the Data Controller on the basis of the consents given prior to revocation.

Finally, you have the right to lodge a complaint with a Supervisory Authority (for Italy, the Garante Privacy).
